Payments

Please send your regular maintenance payments of \$250.00 to Accountsult for Nov 1st and Dec 1st. There are no payment booklets; they will be issued at a later date. Make shutter payments to the Waterside office. The amount if paid by Oct 31st is \$2,800.00, if paid by Nov 30th it is \$2,900.00. For those who have chosen to pay the monthly \$90.00, we will give you further instructions after the board meeting on Nov. 18th. For the special assessment of \$600.00 payable Jan 1st 2007, we will give you further instructions after the board meeting on Nov 18th.
